- < August Cash Balance for the period August 1-19 (interim report due to unavailability of Treasurer for the period Aug. 20-31): \$14,490 start; \$14,059 end. The period Aug. 20- September 30 will be covered at the October BEC meeting.
- < Year 2012 Donations- 28 members (10.3%) have not contributed.
- < The Treasurer's Office reconciles monthly with the Audit Committee as one of the audit safeguards within our branch.
- < Budget vs. Actual Expense- 60% of the budget has been used in 8.5 mo.
