Recipe of the Month

### Madelyn's Veal Scaloppini

1 pound mushrooms, sliced	2 Tbsp. butter
1-1/2 lbs veal steak, thinly sliced and cut into serving pieces	
4 Tbsp. flour	2 Tbsp. butter
2 Tbsp. olive oil	1 clove garlic, crushed
1 cup dry white wine	1 cup chicken broth
2 Tbsp fresh chopped parsley.	Grated peel of 1 fresh lemon
	1/2 tsp each thyme and marjoram
Salt and pepper to taste (I prefer seasoning salt)	
3 Tbsp. dry sherry wine, 2 Tbsp cornstarch	
Juice of one fresh lemon	

Sauté mushrooms in 2 Tbsp butter in skillet. Remove mushrooms from pan and set aside. Flour veal pieces, then brown quickly on both sides

2 Tbsp butter, olive oil and crushed garlic.

Remove garlic, return mushrooms to veal and add all remaining ingredients except sherry wine, cornstarch and lemon juice. Cover pan and simmer gently for about 45 minutes.

Add sherry wine and cornstarch blended with lemon juice to make a smooth paste. (You might have to thin with a small amount of water).

Cook all together 10 to 15 minutes until mixture is thickened and sauce is smooth.



## Health Matters Physical and Mental

### WINTER BLUES

Feeling blue? You may be suffering from what is called "seasonal affective disorder" (SAD). According to the *American Journal of Psychiatry* (August 1996) the condition is related to the amount of daylight present. Sufferers feel up in June, when the days are long, and down in December, when the days are short. While adding light to darkened rooms has proven to be helpful for some, it doesn't work for everyone. Others require antidepressants to get better. "The most important thing to do for SAD patients is to make them aware that the disorder exists, so they can get treated and feel better," says Norman Rosenthal, MD, director of the National Institutes of Mental Health and author of a recent study of the disorder.

### RX FOR ARTHRITIS: EXERCISE

"If it hurts, don't do it" is usually good advice. But when it comes to arthritis, that's not entirely true. Many people who suffer the joint pain and inflammation associated with rheumatoid arthritis tend to avoid exercise because it is uncomfortable. But new research from Tufts University indicates that exercise can actually lessen joint pain. When arthritis patients went through a two-day-a-week, strength-training regimen on exercise equipment, they found walking was easier, balance improved, strength was enhanced, and they had less pain and fatigue. ### A TIME FOR COLD, A TIME FOR HEAT

The application of both cold and heat can be helpful in treating soft tissue (muscles and ligaments) injuries. But the question is when to apply each. Here are the recommendations of Bryant Stamford, PhD, director of the Health Promotion and Wellness Center in Louisville, Kentucky:

Immediately after an injury, apply cold for 10 to 20 minutes to the injured area. Swelling interferes with healing, and cold prevents and/or reduces swelling. Cold also shrinks blood vessels, reduces internal bleeding, prevents muscle spasms and relieves pain. Continue intermittent cold application for 48 hours.

When swelling has gone (usually after 48 hours), the application of heat will stimulate blood flow, promote healing, relax muscles and relieve pain.

# Know Your SIR

Although I confess that I don't recall the incident,



**Donald Lloyd Patterson** is on my birth certificate dated May 28, 1927 in Glendale, California. I do remember that while I was in the first grade, my family moved to Ontario, CA where I continued my schooling and graduated from Chaffey Union High School in 1945 along with 650 other classmates.

The Army rejected me because of a "trick" shoulder I developed while playing varsity football at Chaffey. The game programs listed me as a 165 lb. scat-back, but I barely tipped the scale at 140 pounds.

While working for my father in refrigeration service, I enrolled at Chaffey College where I learned that politics was not for me. I ran for student body business manager, and lost the election by four votes. However, when the popular non-accounting winner failed to register for classes, I was appointed to the position and expected to solve the student body's financial crisis. The crisis had occurred because the current budget had been prepared on the basis of income generated from a very successful football season capped by a victory in the junior Rose Bowl game the previous year.

I met my future wife, **Virginia**, in an accounting class at San Jose State University where she helped me to graduate with a degree in accounting. As my parents were recovering from losses from the Depression, I took employment at American Can Company weekdays from 3 PM 'til midnight to cover expenses. With a full academic load, my only free time to see **Virginia** was between midnight and her 1 AM lockout time.

After graduation, but before marriage and beginning a career with Shell Oil Company in 1952, we both worked a summer for the National Park Service in Yosemite.

I was foreman of the Blister Rust Control Camp at Crane Flat and **Virginia** was the telephone operator at the Park Service exchange in the valley. I had previously worked four summers in Blister Rust Camps at Chinquapin, Wawona and a pack camp on the South Fork of the Tuolumne River.

My twenty-five year career with Shell as an accountant and corporate auditor included assignments with Shell Chemical as well as Shell Oil in San Francisco, Pittsburg, New York, Boston, San Ramon and Walnut Creek. An additional transfer was scheduled for Houston, but I opted for a reduced pension early retirement rather than move to Houston. I accepted a corporate auditor position with Standard Oil of California, now Chevron, and after nine years, took another early retirement in 1986 when

Gulf Oil Corp. was acquired.

We are blessed with two daughters **Carol** and **Laurel**, granddaughter **Robin**, and grandson **Matthew**, who all live and work in the East Bay.

Aside from being born or getting married, the most dramatic time of my life occurred on my daughter's forty-fifth birthday June 28, 1999. Emergency surgery was required to correct my perforated intestine. Two tumors, one the size of a baseball and the other the size of a golf ball along with four feet of my intestines were removed. The surgeon told my wife that I had massive cancer throughout my colon and had only a few days, perhaps a month, to live. After the lab results, I was told that I was "lucky" because I had Carcinoid tumors which grow and move slower than other types of cancer and that some people have been known to live for five years after being diagnosed with Carcinoid.

The thirteen years I've been with SIR have been rewarding and I appreciate all those who contribute to the success of Branch 146, the best SIR Branch.

PS: I began trans-catheter chemo-embolization on the right lobe of my liver on Nov. 18 and on Dec 30 to the left lobe and now am in the recovery stage of this cancer treatment. I plan to be with SIR for at least another thirteen years.




