The Hilton's address is 1970 Diamond Blvd., Concord, CA 94520. The adjacent map illustrates two alternate routes to the Concord Hilton.


Finally, if you know someone who might be interested in joining our branch, don't let the temporary move to the Concord Hilton deter you. Bring your guest to our March luncheon.



On March 13<sup>th</sup> we will be hiking the Round Valley Regional Preserve. This hike is a moderate three-creek, 5 mile tour through rolling hills of oak woods and grassland. There will be about an 800 foot elevation gain and on a scale from 1 to 10, I would say it's a 7 or 8 (my SIR rating). Round

Valley is protected habitat for the San Joaquin kit fox, and Golden Eagle sightings are frequent. The wildlife viewing is exceptional throughout this hike and the spring flowers should be in full bloom on the mountain. I like to do this hike this time of the year because in the summer it's too hot and Marsh Creek should have water in it. We will be having our lunch at the highest point about half way through our hike which will include a beautiful view toward the Delta and beyond.

Directions: Round Valley is about 12 miles past Clayton on Marsh Creek Road (past Morgan Territory Rd.). Anybody wishing to carpool can meet at the Clayton Library parking lot at 9:30 am. Meet at the Round Valley parking lot at 10:00 am.

**Lewis** and **Frank McNamee**. Our next meeting will be hosted by **John Lewis**.




## Poker Group 5

the spell at **Ken Kratz's** home when he hosts our February Poker Group 2.




## Poker Club 4



We welcomed **Ernie Wong** to the trout fishing clan. **Ernie** is noted for his devotion to shad fishing but the shad are only available in June and July so **Ernie** tried his luck for trout at San Pablo Reservoir and caught a pair of rainbows. **Dick Thomson**, **Paul Dubow**, **Harry Sherinian**, **Mike Corker**, and **Carl Moyer** also were on trout outings to San Pablo and Shadow Cliffs Reservoir. Fishing at Shadow Cliffs has been somewhat sparse since we can only fish from shore because the low water level makes the launching of boats impossible. However, we can fish from boats at San Pablo and it has been more productive. On one outing, four anglers landed nine good sized trout.

There were a number of forays outside of Contra Costa County. Our annual trip to the Bass Pro Shop and Fisherman's Warehouse in Manteca was a lot of fun and many dollars were spent on equipment. We finished with a good lunch at the Black Bear Diner. On another food outing, **Ron Maciak**, **Ken Konzak**, **Craig Walton**, **Joe Peterson**, and **Carl Moyer** traveled to Barbara's Fish Trap in Princeton for a terrific seafood lunch. They also brought home pounds of crab, but it was purchased from boats in the harbor. **Paul Dubow** caught a 10 lb skipjack, fishing in Maui, but he and **Karl Droese** came up empty-handed on a steelhead outing in the Smith River in northern California.






## Duplicate Bridge 2






## Nine Hole Golf Group


